This report summarises the findings of the pilot audit undertaken with the Diocese of East Anglia; the aim of the audit was to identify the progress of national safeguarding standards being implemented and embedded.

The audit draws on evidence generated from self-assessment, supporting documentation, interviews and focus groups, Commission observation, surveys and case work analysed by the CSSA. This material was used to rate the Diocese against each of the individual safeguarding standards, with scores from the sub-standards being used to calculate the overall standard grading. The scale of potential gradings is:

*Basic (Below Basic if not achieved), Early Progress, Firm Progress, Results being Achieved, Comprehensive Assurance and Exemplary.*

The key findings of the audit are that the Diocese is at the overall grading of *Comprehensive Assurance* at this time, with two standards achieving a *Results Being Achieved* grading and six achieving a *Comprehensive Assurance* grading<sup>1</sup>. There is work underway to develop practice in key areas of the safeguarding standards, and the Diocese has plans to build further on areas of strength.

Some *Exemplary* practice was seen in relation to safeguarding training, managing/supporting respondents and quality assurance/continuous improvement. Areas for development related to building on existing and planned work, such as engaging with, listening to and learning

from victim-survivors, as well as exploring ways to more regularly monitor volunteer DBS compliance.

It is acknowledged that the Diocese of East Anglia proactively volunteered to assist the CSSA pilot baseline audit programme, highlighting their commitment to safeguarding, quality assurance and ongoing improvement within the Diocese.
